

CAMERA RECORDING CLARIFICATION TEXT

I. Data Controller

According to the provisions of the Personal Data Protection Law No 6698 (PDPL), your personal data is processed by our Company **Biruni Analiz ve Sağlık Laboratuvar Hizmetleri Sanayi A.Ş.**, residing at **Gayrettepe Mahallesi Yıldız Posta Cad. Ayyıldz Sitesi No: 26-A Beşiktaş-İstanbul/Turkey**, acting as the Data Controller within the scope designated below.

II. Personal Data Collection Methods and Legal Reasons

The purpose of this Camera Recording Clarification Text is to inform you that video surveillance equipment has been placed in the entrance and exit doors of the building and its extensions, the exterior of the building and other service areas of the Data controller, and in other areas where there is a warning sign (referred to as the "Compound of the Company"). The video surveillance system records and processes images of individuals and objects passing within range of these systems. The system works continuously 24 hours a day, 7 days a week. Through the video surveillance system, the visual and audio recordings, and camera recordings within the data category, are processed.

Your images are processed by our Company based on the legitimate interests of the data controller and legal reasons.

III. Purposes of Processing Personal Data

Your personal data will be processed by our Company for the following purposes within the scope of the personal data processing conditions and purposes specified in Articles 5 and 6 of the PDPL:

- Execution of Storage and Archiving Activities,
- Ensuring Physical Space Security,
- Ensuring the Security of Movable Property and Resources,
- Providing Information to Authorized Persons, Institutions, and Organizations.

IV. Transfer of Personal Data

Our company exercises all due diligence to process your personal data in accordance with the "need to know" and "need to use" principles, by ensuring the necessary data minimization and by taking the necessary technical and administrative security measures. On grounds, ensuring the security of the compound of the Company, the execution or control of the processes of ensuring compliance with workplace rules, and the operation of digital infrastructures necessitate continuous data flow with different stakeholders, we become obliged to transfer the personal data we process to third parties for certain purposes.

1. In case of a legal dispute, or upon request with the Authorized Public Institutions and Organizations.

V. Rights of the Relevant Person

As the person whose personal data is processed, you can contact kisiselveriresim@biruni.com.tr, or you can use the form provided at the address www.biruni.com.tr in order to exercise your rights under Article 11 of the Law regulating the rights of the person concerned (learning whether your personal data is processed, requesting information about processing, learning the relevance of the processing for the purpose, knowing the persons to whom the transfer is made, requesting correction of incomplete or incorrect processing, requesting deletion or destruction, requesting the notification of all automated transactions to third parties, objecting to the analysis, and requesting compensation of damages) in accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller.
